All sales activities relating to new sales for the products listed above are to be ended according to the milestone dates published below. New service contracts should no longer be entered into, and existing rental agreements and service contracts should not be prolonged after expiration.

Successor Product/Solution

M43 Order Stop

The order stop for the products mentioned above takes effect on 5th of Jun 2017. Please budget any additional demand beyond this date and place the order early enough.



The end of hardware and software support by development occurs on June 30th 2020. From this point on no more error correction will take place. Instead, the customer must migrate to the successor products.

M45 Order stop for expansions

The order stop for the products mentioned above for new and expansion business takes effect on 5th of Jun 2017

Not affected are the available accessories like Key Modules and Wall Mount Kits.

All electronic customer relevant documentation like User Manuals will be available until the end of all product activities.

M5 End of product activities

All product activities under responsibility of headquarter will be terminated on June 30th 2022. Any other regional product activities and their associated liabilities are the responsibility of the respective sales region.
