#### Introduction

As part of the continued portfolio refinement and ongoing hardware simplification we are announcing the lifecycle for a number of items in the OpenScape Business family. This phase-out is being initiated due to the very low demand of sold OpenScape Business X3W/X5W housings/systems and an increasing preference for the rack mounted systems.
