New Software Assurance Re-enlistment Policy

Product Bulletin – PB2018June1C June 1st, 2018





1 SUMMARY

To encourage Software Assurance renewals and reactivations, Mitel is changing its Software Assurance reenlistment policy for many of its products.

Effective July 2018:

- **No Grace Period**: late renewals are considered as re-enlistments from the first day after the Software Assurance subscription end date.
- The re-enlistment fee is equivalent to 20% of 1 year of Standard Software Assurance.
- Quotations for Software Assurance renewals and re-enlistments are valid for up to 120 days.

2 PRODUCT OVERVIEW / FEATURES & BENEFITS / DESCRIPTION

2.1 MODIFICATIONS

The following modifications are applied to the Mitel Software Assurance program:

2.1.1 GRACE PERIOD

The 30-day Grace Period is removed from products where this was previously in place. Late renewals are considered as re-enlistments from the first day after the SWA end date. This encourages on-time renewals, decreasing the risk of absence of SWA coverage between expiry and renewal.

2.1.2 RE-ENLISTMENT PRICE

The price of the re-enlistment fee is decreased, from 100% down to 20% of 1 year of Standard Software Assurance.

Reminder: when re-enlisting, besides the re-enlistment fee, a minimum 1 year subscription of Software Assurance is required.

2.1.3 QUOTATION VALIDITY

The maximum validity duration of Software Assurance renewal and re-enlistment quotations increases from 90 days to 120 days.

Also, quotations created before the Software Assurance end date are valid for 120 days or until the Software Assurance subscription end date, whichever comes first.

2.2 APPLICABLE PRODUCTS

These modifications apply to the products licensed in AKOP, AMC and SLS, plus MiVoice Call Recording.

MiVoice Connect Partner Support already complies, so no change is being made on the re-enlist policy or quote/order processing for this.

There is no change to the prices of re-enlistment fees as provided for the support programs of various 3rd-party products offered through Mitel. See the "Supporting material" section below for more details. The absence of Grace Period and the new quotation validity rules, however, also apply to 3rd-party products.

Toshiba IPEdge (SUS) is supported under its current policy until further notice.

2.3 APPLICABLE REGIONS

These modifications apply globally.

2.4 TIMING

2.4.1 EFFECTIVE DATES

The modifications are effective at the following dates:

- Products licensed in AKOP and SLS: July 4th, 2018
- Products licensed in AMC and MiVoice Call Recording: July 18th, 2018



2.4.2 TRANSITION

Quotations created before the effective dates above will be orderable until they expire.

3 SUPPORTING MATERIAL

The following table lists re-enlistment part numbers by product, whether or not their price is modified and, if yes, how this price change is implemented:

- "Unit price modified": the price of the part number is changed to match the new policy;

4 QUESTIONS & ANSWERS

Part number

Description

Q: I create a Software Assurance renewal quotation a short time before the subscription end date. It does not include re-enlistment fees. Can I purchase it after the subscription end date?

A: No: quotations created before the subscription end date expire at the latest on the subscription end date, even if less than 120 days have elapsed. If the order is not received before or on the subscription end date, then a new quotation must be generated after the subscription end date. This new quotation includes reenlistment fees and is valid for 120 days.
